**24.11.02 Minutes of the Ordinary Meeting** held on 07.11.2024 were circulated to the councillors in advance, approved and signed by the vice chairman and the clerk.

**24.11.03** To receive declarations of interest by members in respect of items on the agenda. Cllr Vernon declared an interest in P/2024/00696 planning application for Moreton Brook Solar Farm.

**24.11.04** Matters Arising from the Minutes There were no matters arising from the minutes.

# 24.11.05 Clerk Update

- a) Green Waste Collection The ESBC councillors are trying to fight the brown bin tax.
- b) We have received an invitation to have a tree at the St Nicholas Church Abbots Bromley Christmas tree festival. The parish council decided not to take up this invitation.
- c) Robert Pritchard the new county officer of the SPCA has commenced work.
- d) The SPCA AGM is on 16 December 2024 in Stafford. Cllr Atkins will try to attend.
- e) Emergency plan for the unexpected absence of parish clerk instructions have been given to the Chairman and Vice-Chairman.
- f) East Staffordshire Borough Council are holding a Town and Parish Forum on 21 November 2024.
- g) Agree dates of future meetings 6 March 2025, 15 May 2025, 3 July 2025, 28 August 2025. These were approved.
- h) NALC have a new website. Councillors are encouraged to set up their own accounts so that they can access all the information on it.
- i) Staffordshire County Council are working on a Local Transport Plan, more information can be found on the parish council website.
- j) National Joint Council for Local Government Services (NJC) has reached an agreement on rates of pay applicable from 1 April 2024 to 31 March 2025. The clerk should now be paid £14.36/hour (SCP12) back dated to 1 April 2024 in line with her contract. The parish council resolved to pay the clerk the new rate with back pay.

The parish council had planned to have held an informal meeting with a representative of Aura Power prior to this parish council meeting, but due to a misunderstanding, there representative missed the meeting. A further informal meeting is scheduled for 14.11.2024.

The parish council will arrange a Public meeting on Wednesday 27 November 2024 at 7pm. Aura Power have been invited to attend. This will be followed by a Planning Meeting.

e) P/2019/01105 Leaways, Newton – apparent non-compliance with planning decision.

The planning enforcement officer suggested that we write to the resident to ask them to remove the black polythene from the grass verge, as it is not a breach of planning regulations. He also stated that it is hoped that the hedge be planted by the end of November 2024.

- d) Grit bin Rectory Farm the clerk will check the grit bins.

- h) ESBC and Admaston signage upgrade on B5013 Staffordshire County Council have now agreed that they are responsible for removal of the ESBC sign if ESBC are not willing to replace it. Clerk has asked that they remove it and lower the Admaston sign to the usual height of village signs. The clerk will chase the SCC and at the same time make enquiries about adding 'please drive carefully signs'.

Thanks to resident Mr Paul Riley for straightening the Newton sign which had been bent by the verge mower.

The clerk will follow up a report of potholes on Steenwood Lane.
